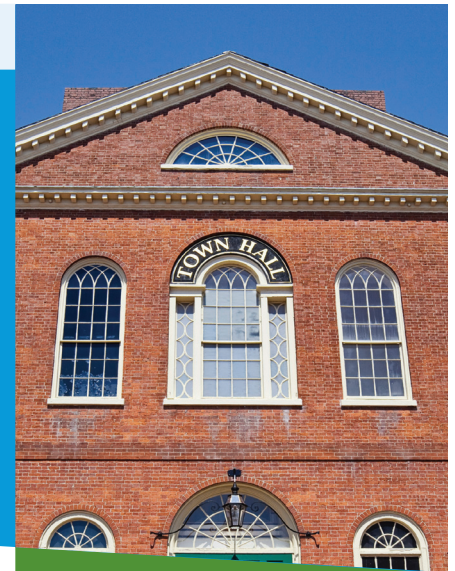

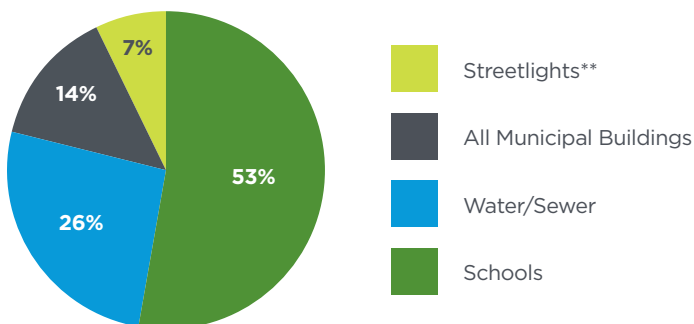

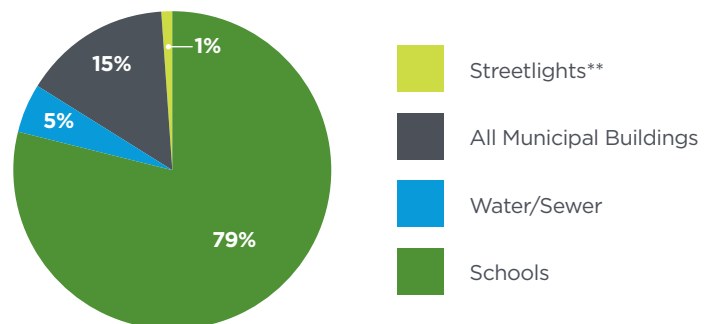
The Department of Energy Resources (DOER) Can Help Municipalities Work with Mass Save
