The Expanded HEAT Loan Initiative offers customers the opportunity for a 0% loan for the installation of qualified energy-efficient improvements in their homes. **An Expanded HEAT Loan Authorization Form is required before a customer can apply for a loan with a Participating Credit Union or Bank (Lender).**
