The Mass Save® ENERGY STAR® certified induction and electric radiant cooktop rebate is available to Massachusetts residential natural gas and propane customers where the Mass Save program is offered by Berkshire Gas, CapeLight Compact, Eversource, Liberty, National Grid and Unitil. This rebate is only eligible when replacing an existing natural gas or propane stove. Customers must submit photos of their existing propane or gas stove as well as a photo of the new induction or electric radiant cooktop stove to be eligible. Photos must show the existing cooktop before removal and the new cooktop after installation with the surrounding area in the frame. This rebate is good for the installation of an induction stove between January 1, 2025 and December 31, 2025. The rebate application and all necessary materials must be postmarked or submitted online by January 31, 2026. Limit one cooktop rebate per Massachusetts residential household.

## INSTRUCTIONS

1. This rebate is only eligible when replacing a natural gas or propane stove with an induction or electric radiant cooktop. Customers must submit a before and after photo of their existing cooktop and the new cooktop installed with their application to qualify. Photos must be in the same location showing the area around the cooktop.
2. Purchase an induction or electric radiant cooktop between **January 1, 2025 and December 31, 2025**.
3. Submit your rebate information online at [MassSave.com/Savings](https://MassSave.com/Savings) or mail it to the address on the right **no later than January 31, 2026**. We cannot process your rebate without the following information:
  - This completed rebate form
  - A copy of the receipt showing the qualifying product including the purchase date, purchase price, model or sku #, and store name
  - DO NOT mail with your utility bill payment
  - A photo of your existing gas or propane cooktop and the new induction cooktop once installed.
