Eligibility

In addition to existing residential heat pump eligibility criteria:

- Heat pumps must be new and sized to be capable of being the sole source of heating in the home. Contractors must install equipment sized to meet 90-120% of the total heating load at the outdoor design temperature, per ACCA Manual J Design Conditions, throughout 100% of the conditioned space. Manual J and/or Manual D documentation only required upon request.
- Project must either include the removal or disconnection of the pre-existing heating system. If the pre-existing system will remain in place, homeowner must not use the pre-existing heating system except for domestic hot water heating (e.g., indirect storage tank or combination boiler). Space heating must be disabled in these scenarios.
- Home must be sufficiently weatherized prior to heat pump installation. Sufficient weatherization can be demonstrated by satisfying at least one of the following requirements: (A) home was built during or after 2000, (B) Home Energy Assessment report indicates less than \$1,000 worth of weatherization recommended or (C) weatherization recommendations made during or after 2013 have been completed. Supporting documentation only required upon request
- Homes must be individually metered 1-4 unit buildings or townhouses and must be occupied full time during the winter heating season. Apart from townhouses, customers in 5+ unit homes are not eligible for whole-home heat pump rebates and should contact the Mass Save multi-family program prior to installation. (A townhouse is defined as a single-family dwelling unit constructed in a group of three or more attached units in which each unit extends from foundation to roof.)
